## SECTION 4: First-aid Measures

### 4.1 Description of First Aid Measures

**GENERAL NOTES:** When symptoms persist or in all cases of doubt seek medical advice. Show this safety data sheet to the doctor in attendance.

## 7.1 Precautions for safe handling

Keep working clothes separately. Keep away from food, drink and animal feedingstuffs. Wash hands before breaks and at the end of workday. When using, do not eat, drink or smoke.

### 4. First-aid Measures
