4. First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: When symptoms persist or in all cases of doubt seek medical advice. Show this safety data sheet to the doctor in attendance.

8.2 Exposure controls

HAND PROTECTION: Use chemical resistant gloves (EN 374): Butyl rubber; thickness >= 0,5 mm; breakthrough time >=60 min. Use chemical resistant gloves (EN 374): Nitrile rubber; thickness >=0,5 mm; breakthrough time >= 480 min. Isocyanates can harden gloves and increase the risk of their splitting. Gloves should be discarded and replaced if there is any indication of degradation or chemical breakthrough.
